A RESOLUTION

Setting forth the total funds estimated to be available from the United States Grant Fund, the Revenue Fund and the Foreign Assistance Fund for the fiscal year ending September 30, 2006, and requesting the Governor to notify the Legislature of any changes in the amount available from the funds of the Treasury.

WHEREAS, pursuant to the Kosrae State Code, Section 10.306, for each fiscal year the Legislature adopts a resolution stating the total funds estimated to be available for 2 appropriation from each of the funds of the Treasury for the coming fiscal year, based on 3 4 all available information; and WHEREAS, Kosrae State Code, Section 10.206, states that the United States 5 Grant Fund contains all monies received from the United States Government, except 6 United States federal agency program monies; and 7 WHEREAS, Kosrae Sate Code, Section 10.205, states that the Revenue Fund 8 contains all monies from Government's collections through taxes, duty or tariff, and all 9 other revenues or reimbursements from a fine, fee or license, interest, rent or service and 10 other collections by a government for the Government's benefit, with certain exceptions; 11 12 and WHEREAS, Kosrae State Code, Section 10.207, states that the Foreign 13 Assistance Fund contains all monies not belonging to the Revenue Fund and received by 14 the Government for its use from other governments, governmental agencies or other 15 external sources other than the United States Government; and 16 WHEREAS, the information available includes information from the Governor's 17 estimates of the funds to be available as set forth in the budget submission, as well as 18 estimates based on past experiences with the Foreign Assistance Fund; and 19 20 WHEREAS, any estimates in the amount available from the Revenue Fund and other funds of the Treasury are subject to change; now, therefore 21 22 BE IT RESOLVED, by the Eight Kosrae State Legislature that the total funds estimated to be available for appropriation from each of the funds of the Treasury are as 23 24 follows: 25 I. The United States Grant Fund 10,877,829 26 Sector Grants 8,405,600 27 Supplemental Education Grant 2,098,254 28 Inflation Adjustment 123,562√ 29 Unused Sector Grants FY05 250,413 30 II.
