A BILL FOR AN ACT

To appropriate the sum of \$3,000.00 (donation from Da Yang) from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2024 Micro Games in RMI; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Appropriation. The sum of \$3,000.00 (donation from Da Yang) is hereby 1 appropriated from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2 3 2024 Micro Games. Section 2. Apportionment. The amount shall be apportioned as follows: 4 1. 2024 Micro Games in RMI 5 \$3,000.00 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted, 6 managed, administered, and accounted for in accordance with applicable laws. The allottee of the funds 7 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that 8 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated 9 and that no obligations are incurred in excess of the sum appropriated. 10 Section 5. Effective Date.
