Dear Speaker Phillip,

I extend my compliments and warm greetings to you and the members of the 13th Kosrae State Legislature.

Pursuant to Article IV, §16 of the Kosrae State Constitution, I am returning this bill, affixing my signature to section 2, at subsections (1) through (4), as line item veto to L.B. No. 13-22, L.D.1.

It is apparent that this appropriation bill seeks funding for the "Liberation Celebrations" for the four municipal governments, in support of the growth of the agriculture and fisheries development in the State.

I understand the rationale behind the subject bill; however, I have recently transmitted a proposal shifting funding from the Foreign Assistance Fund to the Local Revenue to source the operations of the locally funded entities of the government. These entities are in dire need to source their operation obligations, which are almost depleted as addressed in my transmittal letter on May 15, of this year.

As you are aware of, the national government subsidies we are anticipating to assist the Foreign Assistance funding of our budget has been redirected to the road and shoreline projects.

Mr. Speaker, my action to L.B. No. 13-22, L.D. 1, is to ensure that the core obligations of the government is taken care of without disruption, even at the bare minimum, with the limited local revenue source we have. I am not aware of the urgency of the subject bill, as we have few more months before the Liberation month and by July we will definitely know the outcome of the referendum we are anticipating to increase our revenue.

A BILL FOR AN ACT

To appropriate the sum of \$\frac{18,000.00}{18,000.00}\$ from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2023 Liberation Celebrations for the four municipal governments in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Appropriation. The sum of \$18,000 is hereby appropriated from the 2 Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2023 Liberation Celebrations for the four municipal governments in the State of Kosrae. The 3 funding assistance is recommended as prime supports to the goals and objectives set in the 4 5 Kosrae State Strategic Development Plan (SDP). The Kosrae State SDP specifically 6 pledges for the state's strong support to the growth of our economy, most especially the 7 areas of agriculture and fisheries development. Hence, the fair competition event is the 8 principal intent of this funding assistance, supported by this bill. 9 Section 2. Apportionment. The amount shall be apportioned as follows: 000.00 (1) Lelu Municipal Government \$5,000.00 10 3.000.00 (2) Tafunak Municipal Government 11 (3) Malem Municipal Government 12 (4) Utwe Municipal Government 13 14

Section 3. Allotee and Lapse Date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable law. The

1	allottee of the fund appropriated shall be the Governor of the State of Kosrae, who shall be
2	responsible for ensuring that these funds, or so much thereof as may be necessary, are

5	Section 4. Effective Date. This act takes effect upon the approval of the Governor
