A BILL FOR AN ACT

To appropriate the sum of \$12,000 from the Local Revenue Fund of the Kosrae State Treasury to provide additional subsidy for the operation of the Utwe Water System; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$12,000 is hereby appropriated from the Local Revenue
2 Fund of the Kosrae State Treasury to provide additional subsidy for the operation of the Utwe Water
3 System.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
5 managed, administered, and accounted for in accordance with applicable laws. The allottee of the funds
6 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
7 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
8 and that no obligations are incurred in excess of the sum appropriated.

9 Section 5. Effective Date. This act takes effect upon the approval of the Governor or upon its
10 becoming law without such approval.
