A BILL FOR AN ACT

To appropriate the sum of \$12,000.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding sports uniforms for the athletes and coaches participating in the upcoming Micronesian Games in the Republic of the Marshall Islands (RMI); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Appropriation</u>. The sum of \$12,000.00 is hereby appropriated from the
- 2 Revenue Fund of the Kosrae State Treasury for the purpose of funding sports uniforms for
- 3 the athletes and coaches participating in the upcoming Micronesian Games in the Republic
- 4 of the Marshall Islands (RMI); and for other purposes.
- 5 Section 2. <u>Apportionment</u>. The amount shall be appropriated as follows:
- 1. Sports uniforms for upcoming Micronesian Games (RMI) \$12,000.00
- Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
- 8 allotted, managed, administered, and accounted for in accordance with applicable laws.
- 9 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
- shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
- are used for the purpose for which are appropriated and that no obligations are incurred in
- 12 excess of the sum appropriated.
- Section 4. Effective Date. This act takes effect upon the approval of the Governor
- or upon its becoming law without such approval.
