A BILL FOR AN ACT

To amend the Kosrae State Code by inserting a new subsection (4) under Chapter 2 of Title 17, to establish an apportionment (in fractions) from fees collected from motor vehicle registrations; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by
2	inserting a new subsection (4) under Chapter 2 of Title 17, to establish an apportionment (in
3	fractions) from fees collected from motor vehicle registrations.
4	Section 2. Amendment. A new Section 17.204(4), Chapter 2, Title 17, is hereby inserted to
5	read as follows:
6	"Section 17.204. Fees. Any person(s), government offices or agencies registering a vehicle
7	pays a fee according to the following:
8	(1) Motorcycle, ten dollars;
9	(2) Jeep, sedan, or other vehicle not specified in subsection (3), fifteen dollars;
10	(3) Pickup, truck, bus, or other vehicle not specified in subsection (1) and (2),
11	according to weight in pounds at the time of original sale in the State:
12	(a) Under two thousand pounds or fraction thereof, twenty dollars;
13	(b) Two thousand to two thousand nine hundred ninety-nine pounds or
14	fraction thereof, twenty-five dollars;

1	(c) Three thousand to five thousand nine hundred ninety-nine pounds or
2	fraction thereof, thirty -five dollars;
3	(d) Six thousand to seven thousand four hundred ninety-nine pounds or
4	fraction thereof, forty-five dollars.
5	(e) Seven thousand five hundred pounds and over, one hundred-five dollars.
6	(4) Fees collected from the types of motor vehicle registrations above shall be
7	apportioned (in fractions) and distributed as follows:
8	(a) Fifty percent (50%) Kosrae State Treasury;
9	(b) Thirty percent (30%) Municipal Governments (4) [distribution
10	dependent upon license plate display of municipal jurisdiction: "L" for Lelu,
11	"T" for Tafunsak, "M" for Malem, and "U" for Utwe];
12	(c) Ten percent (10%) Division of Public Safety (DPS);
13	(d) Ten percent (10%) Dept. of Transportation & Infrastructure (DT&I)
14	Revolving Fund.
15	A person who acquires a vehicle after January pays a registration fee for the fraction
16	of the months prior to the next annual registration."
17	Section 3. Effective Date. This Act takes effect upon the approval of the Governor or upon
18	its becoming law without such approval.
