

A BILL FOR AN ACT

To appropriate the sum of \$634,501.00 from the Amended Compact Fund of the Kosrae State Treasury for the purpose of funding the Kosrae – PMO and the IMF Project in the State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Appropriation. The sum of \$634,501.00 is hereby appropriated from the
- 2 Amended Compact Fund of the Kosrae State Treasury for the purpose of funding the Kosrae –
- 3 PMO and the IMF Project in the State.
- Section 2. Apportionment. The sum of \$634, 501.00 appropriated in this act is
- 5 apportioned as follows:
- 1. Kosrae PMO \$183,350
- 7 2. IMF Project(s) \$451,151
- Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
- 9 managed, administered and accounted for in accordance with applicable laws. The allottee of
- the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
- ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
- which are appropriated and that no obligations are incurred in excess of the sum appropriated.
- The authority of the allottee to obligate the fund appropriated by this act shall be lapsed on
- 14 September 30, 2023.
