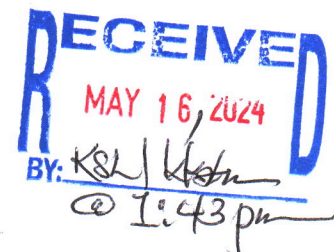



BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 13-72, by
2 amending Section 2 to include funding assistance to the 2024 FESTPAC; and for other
3 purposes.


4 Section 2. Amendment. State Law No. 13-72, Section 4 is hereby amended to
5 read as follows:

6 “Section 2. Apportionment. The amount appropriated in Section 1 of this
7 act is apportioned as follows:

- 8 1. Airfare for Kosrae Delegation (2024 Micronesian Games) \$69,799.00
9 2. Funding assistance to the 2024 FESTPAC \$20,000.00”

10 Section 3. Effective Date. This Act takes effect upon the approval of the Governor
11 or upon its becoming law without such approval.


