## A RESOLUTION

4	WHEREAS, Section 7.601 of Title 7 of the Kosrae State Code established the Kosrae
5	Authority (thereafter referred to as "KPA") and Section 7.602 mandate it to oversee provision to
6	the authority services; and
7	WHEREAS, pursuant to Section 7.606 of Title 7 of the Kosrae State Code, KPA is
8	governed by a Board of five Directors, to be appointed by the Governor with the advice and
9	consent of Legislature and an ex-officio, the Director of the Department of Transportation and
10	Infrastructure; and
11	WHEREAS, by Governor Message No. 12-59, Honorable Governor Carson K. Sigrah
12	has re-nominated Mr. Allerson Alik to be a member of the KPA Board of Directors; and
13	WHEREAS, The Joint Standing Committees on Resources and Development (R&D) &
14	Environment, Transportation, Communication, and Infrastructure (ETC&I) has been assigned to
15	work on the re-nomination and has concluded its work on the re-nomination of Mr. Allerson Alik
16	to KPA Board of Directors; and
17	WHEREAS, it is the finding of the Joint Standing Committees on R&D and ETC&I that
18	the nominee is qualified and able to carry out the duties and responsibilities of a member of KPA
19	Board of Directors; NOW THEREFORE;
