## A BILL FOR AN ACT

To amend State Law No. 13-46, by amending the salary of certain exempt positions under Title 5, Title 6, Title 10, and Title 11 of the Kosrae State Code; and for other purposes.

### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this amendment is to amend State Law No. 13-1 2 46, by amending the salary of certain exempt positions under Title 5, Title 6, Title 10, and 3 Title 11 of the Kosrae State Code; and for other purposes. 4 Section 2. Amendment. Title 5, Section 5.501 is hereby amended to read as follows: 5 "Section 5.501. Salary of Governor. Lieutenant Governor and Directors. The 6 7 annual salary of the Governor is thirty-four thousand and seven hundred thirteen twenty-8 two thousand eight hundred dollars (\$34,713.0022,800.00). The annual salary of the 9 Lieutenant Governor is thirty thousand and three hundred seventy-five nineteen thousand 10 and nine hundred fifty dollars dollars (\$30,375.00 19,950.00). Unless otherwise provided 11 by contract for the employment of a professional providing professional services, the 12 annual salary of a director of a department is twenty-six thousand and thirty-five dollars 13 seventeen thousand one hundred dollars (\$26,035.00 17,100.00), however a department director who possesses a doctoral degree (PhD) shall receive an annual salary of no more 14 15 than thirty-eight thousand and sixty-three dollars twenty-five thousand dollars (\$38,063.00 16 25,000). A director has no leave benefits. A director makes himself available at all times 17 for the performance of his duties."

Amendment. Title 11, Section 11.609 is hereby amended to read as 6 follows: 7 "Section 11.609. Compensation. The Principal Land Justice shall receive 8 an annual compensation in the amount of twenty-six thousand and thirty-9 five-seventeen thousand one hundred dollars (\$26,035.00 17,100.00). The 10 Associate Land Justices shall receive an annual compensation in the 11 amount of twenty three thousand and one hundred forty-two fifteen 12 thousand two hundred dollars (\$23,142.00 15,200.00). The amount of 13 compensation shall not be increased or decreased during their terms of 14 office, except by general law applying to all State Government employees." 15 Section 6. Effective Date.
