

A BILL FOR AN ACT

To amend the Kosrae State Code by inserting a new Chapter 18 under Part III of Title 7, to establish the Office of the U.S. Armed Forces – Active Duty and Veterans Affairs in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Findings and Purpose. The Legislature of Kosrae State finds that there
2	is a critical need to address the welfare, rights, and re-integration of U.S. Armed Forces
3	active duty personnel and veterans residing within the State of Kosrae. The establishment
4	of an Office dedicated to providing support and services to these individuals will
5	strengthen the relationship between Kosrae State and the United States of America and
6	ensure the appropriate allocation of resources. The purposes of this Act are (1) to amend
7	the Kosrae State Code by inserting a new Chapter 18 under Title 7, to establish the Office
8	of the U.S. Armed Forces – Active Duty and Veterans Affairs in the State of Kosrae; (2)
9	Allocate an initial annual budget of \$900,000.00 from the 2023 Compact of Free
10	Association (COFA) Sector Fund, beginning in the Fiscal Year 2024; and (3) Create a
11	mechanism for future funding from unused Kosrae State funds.
12	Section 2. Amendment. A new Chapter 18 under Part III of Title 87 is hereby
13	inserted to read as follows:
14	"Chapter 18. Kosrae Office of the U.S. Armed Forces – Active Duty and Veterans
15	Affairs Act of 2024.



1	(a). An annual budget of \$900,000.00 shall be obligated from the 2023
2	Compact of Free Association Sector Fund, beginning with the Fiscal Year
3	2024, for the operations and programs of the Office."
4	(b). In addition to the annual budget, additional appropriations for this
5	Office shall be drawn from Kosrae State's annual unused funds, whereby
6	90% of any unused funds from the state's budget shall be allocated to the
7	Office of U.S. Armed Forces Active Duty and Veterans Affairs for future
8	fiscal years.
9	Section 7.1805. Appointment of the Director.
10	(a) The Office shall be led by a Director, who shall oversee its operations
11	and programs;
12	(b) The Director of the Office shall be nominated by the Governor of

15	(c) The Director shall serve a term of four (4) years and may be
16	reappointed following the same process outlined in this section;
17	(d) The annual salary of the Director is tweny-one thousand nine hundred
18	ninety-five dollars (\$21,995).
19	Section 7.1806. Qualifications of the Director. The Director shall be required to
20	have the following qualifications:

1	(a) Demonstrated experience in veterans' affairs or public administration;
2	(b) Knowledge of U.S. military protocols and veterans' benefits programs;
3	(c) Commitment to addressing the needs of veterans and active duty
4	personnel.
5	Section 7.1807. Reporting and Accountability.
6	(a) The Office shall submit an annual report to the Governor and the
7	Kosrae State Legislature detailing the services provided, the number of
8	veterans and active duty personnel served, and the financial expenditures
9	for the year.
10	(b) The Office shall be subject to an annual audit to ensure transparency
11	and proper use of allocated funds."
12	Section 3. Effective Date. This Act takes effect upon the approval of the Governor
13	or upon its becoming law without such approval.
