

FSM States Consultation

Development of FSM SDG 7 Road Map and Review of FSM National Energy Policy Background

- The 2012 FSM National Energy Policy (NEP) is to be revised and updated to align with new targets established under various national, regional, and global policies including the United Nation Sustainable Development Goals (SDG) \$DG 7, the UNFCCC Updated Nationally Determined Contributions (NDC), Framework for Energy Security and Resilience in the Pacific (FESRIP): 2021 – 2023 and others.
- 2. There has been progress made in achieving the 2012 NEP butcomes however there are remaining key gaps and challenges.
 - The 2012 FSM NEP did not include baseline data; therefore, baselines and future energy demands against the energy targets should be included in the Revised NEP.
 - The 2018 Energy Master Plan provided updates only on four key national energy policy targets (not all energy policy targets) of electricity access, percentage of electricity generated from renewable sources, diesel use, and carbon dioxide (CO₂) emissions up to 2037. Other targets on energy efficiency, these targets need to be captured in the Revised FSM NEP.
 - To update targets to other relevant planning documents that such as the SDP 2004-2023, Infrastructure Development Plan 2016-2025, andNationwide Integrated Disaster Risk Management and Climate Change Policy 2013.
 - To include indicators that are measurable and tangible. For example, the PRIF Energy Indicators and the SDG indicators, FSM identified and prioritised 4 indicators for SDG 7.
 - Monitoring of the progress remains a challenge, therefore a monitoring mechanism for reporting should be established. The monitoring and evaluation framework should include gender-responsive indicators, such as women's representation in the energy sector, increased productive use of electricity, etc.
 - enhance the local capacity to plan, design, implement, manage, operate, and maintain installed energy technologies as the country moves into a carbon free electrification.
- 3. The SDG 7 Roadmap is being developed with the support of UN-ESCAP and it is a guiding document for FSM in reaching its Goal No. 7. The SDG 7 Roadmap will contain a matrix of technological options and enabling policy measures for the National and State Governments to consider. The SDG 7 Roadmap in an implementation planto the revised NEP.
- 4. This State workshop is therefore to collect views and inputs for the review exercise and to build consensus and ensure there is local buy-in to the revised NEP and the development of the SDG 7 Roadmap
- 5. The workshop is planned for two days to be delivered as in the proposed agenda.
