It gives me great pleasure to extend my compliments and warm greetings to you and the members of the 13th Kosrae State Legislature. I am pleased to transmit herewith a revised FY 2024 budget request for the Project Management Office for legislative review and favorable consideration.

The hospital project and other anticipated projects for the state would require an expanded role and capacity of our PMO. Project management and monitoring aside, an improved capacity of this office for timely preparation and submittal of project proposals under the 2023 amended compact would be in the state's interest.

Mr. Speaker, I am requesting legislative endorsement not only because it is required under the budget transmission act but I also believe your endorsement at this stage would ensure its proper and timely consideration and approval by the JEMICO. This revised budget would have been incorporated into the FY2024 proposed budget that was passed on first reading if I had the time and resources to do so. My office missed that opportunity hence its submission now.

For your information, due to the tight timeline going forward my staff is progressing this request through the national government compact management office anticipating the JEMCO's meeting normally held in August.

My office and the PMO will be available to assist the legislature on this matter and we look forward to your favorable consideration.

Kosrae Hospital, Preparations for Compact III

Dear Sir.

We are pleased to note that the Contractor has signed the Contract for the Kosrae Hospital, but I note that there were many conditions under which the grant release was issued to FSM by OiA. As such, please action the following items urgently:

- Engagement of USACE Construction Manager to commence supervision services by September 1, 2023; see attached signed CoR Designation Letter;
- Acquisition of Bonds and Insurance from GPPC by July 12th 2023;
- 3. Issuance of approved Notice to Proceed immediately thereafter (2) above;
- GPPC's immediate commencement of acquisition of necessary state permits and temporary works thereafter;
- 5. Completion of additional Design Work from BECA by September 30th 2023;
- Negotiation of final price from GPPC for Work specified in (5) above and secure clearance from USACE to commence permanent Works by November 2023;

In addition to these items, Kosrae State recognizes the need to upgrade the operations of the Kosrae PMO Office to be ready for Compact III implementation. As such, please take action on the following urgently:

Secure commercial lease space for the PMO Office, allowing for a staff of at least seven (7) persons by the end of this fiscal year:
