A BILL FOR AN ACT

To appropriate the sum of \$89,799.00 from the Revenue Fund of the Kosrae State Treasury for the purpose of funding the airfare for the Kosrae delegation to the 2024 Micronesian Games in the Republic of the Marshall Islands (RMI); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Appropriation</u>. The sum of \$89,799.00 is hereby appropriated from the
 Revenue Fund of the Kosrae State Treasury for the purpose of funding the airfare for the
 Kosrae delegation to the 2024 Micronesian Games in the Republic of the Marshall Islands
 (RMI); and for other purposes.

 Section 2. <u>Apportionment</u>. The amount appropriated in Section 1 of this act is
 apportioned as follows:
- 7 1. Airfare for Kosrae Delegation (2024 Micronesian Games) \$89,799.00
- 8 Section 3. <u>Allottee</u>. All funds appropriated by this act shall be allotted, managed,
- 9 administered, and accounted for in accordance with applicable laws. The allottee of the
- funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
- for ensuring that these funds, or so much thereof as may be necessary, are used for the
- purpose for which are appropriated and that no obligations are incurred in excess of the
- sum appropriated.
- Section 4. Effective Date. This act takes effect upon the approval of the Governor
- or upon its becoming law without such approval.
