A BILL FOR AN ACT

To amend State Law No. 13-48, as amended by State Law No. 13-37, by amending Section 2 at subsection (1)(c), Section 4 at subsection (c), and Section 6 at subsection (c), to modify the Executive, Legislative and Judiciary Branches' respective FY2024 approved budget for representation fund under Contractual; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this Act is to amend State Law No. 13-48, as amended by  
2 State Law No. 13-37, by amending Section 2 at subsection (1)(c), to modify the Office of the  
3 Governor's FY2024 approved budget for representation fund under Contractual; and for other purposes.
