Contract between: Micronesia Conservation Trust and State Government of Kosrae

Supported Position: State Protected Area Network/Blue Prosperity Micronesia Coordinator

Project period: June 1st, 2023 - May 31st, 2024 (12 months)

Introduction: This Contract originated in the Federated States of Micronesia (FSM), state of Kosrae between the Micronesia Conservation Trust (hereafter called MCT), the Waitt Institute and the State Government of Kosrae, Department of Resources and Development and Department of Treasury (hereafter called Kosrae State). This Contract shall be supported by funding MCT received from the Waitt Institute on behalf of the Blue Prosperity Micronesia Program. The State Protected Area Network/Blue Prosperity Coordinator (hereafter called the PAN/BPM Coordinator) shall carry out the activities under the Reference (Annex I). MCT will provide one year of salary, fringe benefits (\$21,153.00) and contribution to operating costs including internet, office space, fuel costs, etc. (\$3,847.00) for this position for a total of \$25,000. The administration of this position and funding shall be the responsibility of the State.

- 1. Subject of Contract: The subject of this Contract is to define the organization of this partnership by defining the rights and obligations of MCT as Blue Prosperity Micronesia fiscal sponsor and the Waitt Institute as the donor in order to successfully implement the above-mentioned project.
 - 1.1. The Services Agreement signed between MCT and the Waitt Institute on September 26th, 2022 is the guiding document for this Contract, and takes precedence over all other agreements. In more detail, all terms and conditions, articles, annexes and guidelines stated in the Service Agreement for this project are part of this Contract. MCT and Kosare State shall be bound to this Contract and Agreement as approved by Waitt Institute.
 - 1.2. On the basis of this Contract, MCT and Kosrae State shall contribute to the achievement of the requirements of the Services Agreement together with other partnering agencies performing to this Contract shall carry out the work in accordance with the timetable using their best efforts to achieve the results specified therein. They shall carry out all of their responsibilities under this Contract in accordance with recognized professional standards.
- 2. Fund Disbursement and Conditions: On the basis of the budget agreed upon between MCT and Kosrae State, and as specified in the Introduction of this Contract, MCT will provide funding to support the position of the State PAN/BPM Coordinator for no more than \$25,000 for 1 year.
 - 2.1. MCT will transfer 50% of the total funds to the State upon full execution of the contract, 40% transfer upon receipt and approval of report (financial and narrative reports) on the 3rd quarterly narrative).

- 5. Specific obligations of the State: Kosrae State shall respect all rules and obligations set forth in the Services Agreement. In addition, the Kosrae State shall:
 - Commit to supporting the State PAN/BPM Coordinator in carrying out the activities specified in the Terms of Reference and foster the implementation of the project:
 - Provide the State PAN/BPM Coordinator the facilities, equipment and material necessary to perform
 - Ensure that the State PAN/BPM Coordinator communicates to BPM on a regular basis through monthly updates via email, phone call or in person meetings;
 - Ensure continuous interaction between Kosrae State and other partnering agencies:
 - Provide MCT both narrative and financial report on a quarterly basts.
 - Inform MCT, Waitt and BPM immediately about any delays in the performance of the activities or any circumstance that could lead to a temporary or final discontinuation of the project at the state
 - Inform MCT, Waitt and BPM about any change in personnel, tasks or procedures of its project team:
 - Maintain a sound accounting code for all transactions relating to the project; Provide to MCT the bank account details to transfer the funds;
 - Keep separate and accurate financial records of the funds provided for the salary of the State
 - Provide to MCT necessary supporting documents relating to the project upon request.
