A BILL FOR AN ACT

To amend State Law No. 13-27, by repurposing the fund to National Women’s Conference scheduled to be held in Kosrae on November 27 through December 2, 2023; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to repurpose the fund previously
2 appropriated for the Joint Committee Meeting held in Kosrae on August 14-15, 2023, to fund the
3 National Women’s Conference scheduled to be held in Kosrae on November 27 through
4 December 2, of this year

5 Section 2. Amendment. State Law No. 13-27 is hereby amended to read as follows:

6 “To appropriate the sum of \$5,000.00 from the Local Revenue Fund of the Kosrae
7 State Treasury for the purpose of funding the ~~Joint Committee Meeting~~ National Women’s
8 Conference scheduled to be held in Kosrae on ~~August 14-15,~~ November 27, through
9 December 2, 2023; and for other purposes.

10 Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the
11 Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the ~~Joint~~
12 ~~Committee Meeting~~ National Women’s Conference scheduled to be held in Kosrae on
13 ~~August 14-15~~ November 27, through December 2, 2023.
